- Held in conjunction with “Homes for the Holidays” Charity Home Tour showcasing Camarillo area homes dressed for the holiday.
- The Boutique will be open from 10 a.m. until 4 p.m. Home Tour will be held 1 p.m. to 5 p.m.
- Refreshments for tour attendees and shoppers will be served at the Red Barn at the Camarillo Ranch.
- The Holiday Boutique will be advertised to the public in advance. Accepted vendors will be asked for publicity photos.

ALL DOCUMENTS AND PAYMENTS ARE DUE WITH THE APPLICATION.

INSIDE: (Every Space is approximate—work with your neighboring vendors in the Barn)

Standard Space:	\$150	(1) 10' x 7' space
Large Space:	\$250	(1) 20' x 7' premier space

OUTSIDE:

Single Space	\$50	(1) 10'x10' single space
Double Space	\$100	(1) 10'x20" double space

OTHER:

Electrical connection:	\$ 20	
Table Rental:	\$ 20 per table	6 ft. or 8 ft. table (available to INSIDE vendors only)

- **Percentage:** Vendor pays 15% of gross sales to Meadowlark Service League at conclusion of event. Be prepared to provide cash or check.
- **Proof of insurance must be provided with Application:** \$2 million General Liability, \$1 million each occurrence is required. Insurance for this event only can be purchased through MSL for \$50.
- **Read and sign this Acknowledgement form, select and complete the INSIDE OR OUTSIDE Application, return all forms with proof of insurance and payment. Applications will be accepted on a first come basis subject to MSL approval.**
- **No refunds available after November 11, 2019.**

MSL will provide rentals of 6' or 8' tables for a fee if paid in advance **ONLY** for **INSIDE VENDORS**. Vendors will supply all merchandise, table linen, chairs and shopping bags. **OUTSIDE VENDORS** must provide their own canopies (they must be secured) in addition to the above requirements. **ALL VENDORS: BRING YOUR OWN CHAIRS AS THEY ARE NOT AVAILABLE.**
