- Silent or Live Auction Item: Vendor to donate item (not a gift certificate) that represents your booth (minimum value of \$50) for the Silent or Live Auction. - Electricity must be requested in advance. There is a charge of \$20 for an electrical connection. Vendor will supply extension cord. (You are to provide your own additional lighting if needed.)
- Please bring your own lunch.

- Space is limited and will be allocated on a first come, first served basis.
- Registration is available online at MeadowlarkServiceLeague.org. Vendor must supply merchandise description at time of Registration. Payment must be made to reserve a space.
- No refunds available after Friday, February 18, 2022.
